

News & Events

- Fuel Reduction:** 50 Acres of vegetation was cleared in the Blackstone, Riverview, Virginia-Gold, Tamaroo Drainage, and Borland-Jordan areas. This clearing was done using grazing livestock for maintenance on previously mechanically treated areas. This \$49,500 grant was awarded through the Placer County Middle Fork Fuel Reduction Program.
- Station 3 Funding:** The Auburn City Council adopted the FY 2021/2022 in which seven firefighters were funded full time allowing the Maidu Fire Station to remain funded permanently.
- Hiring and Promotions:** We have finished the hiring and promotional process for Captain, Engineer, and Firefighter. Stay tuned for the announcement of the new firefighters and promotions!
- PG&E Responder Safety Training:** The Auburn Fire Department hosted an Electrical and Gas Safety training for first responders at Station 1 during second week of May. All on-duty fire personnel attended, as well as representatives from the Public Works Department.

VEGETATION FIRE

Folsom Incident, June 30th – At 12:01pm Auburn Fire resources along with CAL FIRE and several automatic aid agencies responded to multiple roadside vegetation fires along Auburn Folsom Rd. Both Auburn Fire Engine's were able to stop one of the quick moving vegetation fires heading towards several homes. Battalion Chief Zaucha joined in Unified Command with CAL FIRE and deployed several air and ground resources. Auburn Police evacuated several residents and issued an evacuation warning for the neighborhood. A total of four fires were contained. Two fires in Newcastle's District. Two fires in the City of Auburn totaling 2.8 acres. Several fences were damaged but no structures.
