

News & Events

- Fire Apparatus Engineer Testing:** Five members of the Auburn Fire Department are testing for two vacant Fire Apparatus Engineer positions.
- Thermal Imagers:** Thanks to a generous donation from the Mother Lode Model T Club, the Auburn Fire Department was able to purchase two state of the art thermal imaging cameras. These tools enable our firefighters to search for and rescue victims faster from fire and other hazards.
- Internal Driver/Operator Courses:** Battalion Chief Rogers provided six Auburn Fire Department employees with 80 hours of Driver/Operator Instruction. Employees received two certifications from the State Fire Marshall's Office and are better prepared to safely drive and operate fire apparatus.
- Personal Cameras:** The Auburn Fire Department was included in a Sacramento Area Urban Areas Security Initiative grant and will be equipping every riding position with a personal thermal imaging camera. These cameras can potentially save more lives and protect property by increasing two vital parts of an emergency call, speed and firefighter safety.

Significant Emergency Incidents

VEHICLE ACCIDENT

January 8th – Auburn Fire Department responded to a reported vehicle accident for two motorcycles down in the area of Highway 49 and Persimmon Terrace. AFD arrived and found two motorcycle riders with major injuries. APD officers were at scene prior to AFD and applied a tourniquet to one of the patients who had major bleeding from the leg. Battalion 1215 assumed Persimmon Command and both AFD Engines assisted AMR with patient care. The AMR Paramedic at scene requested two additional ambulances; one ground and one air. Persimmon Command requested Mutual Aid from Placer County Fire/CAL FIRE Station 180 for landing zone support. APD closed Highway 49 in both directions for scene safety and a helicopter landing zone. Both patients were transported to Sutter Roseville Medical Center for treatment; one by ground and one by air. AFD units supported APD with scene control while a traffic accident investigation was performed and assisted the tow company with roadway restoration.

HAZMAT

February 24th – Auburn Fire and Placer County Fire/CAL FIRE responded to a reported HAZMAT at the Auburn Airport. Battalion 1215 arrived at scene and found a 700 gallon fuel truck near the fuel island with an active fuel leak. CAL FIRE Battalion 2307 requested their HAZMAT Team. AFD Engine 1285, Placer County Fire Engine 10, and CAL FIRE Engine 2382 arrived at scene. The engine companies isolated and denied entry and evaluated the leak. Battalion 2307 arrived at scene and entered into Unified Command with AFD and APD. Airport Command requested the Roseville Fire Department HAZMAT Team respond to assist with mitigation. The FAA and OES were notified. The fuel spill was estimated to be 50+ gallons of 100LL Aviation Fuel. A private clean-up contractor was requested to clean-up the fuel spill and restore airport operations.
