

News & Events

- Firefighter & Fire Captain Testing:** Firefighter and Fire Captain testing processes have been completed. Three firefighters are now in the hiring process and a Fire Captain should be forthcoming.
- Unified Command Training:** Several Battalion Chiefs participated in a training with CAL FIRE and the Placer County Sheriff focusing on Unified Command of major emergencies. They simulated types of all-risk emergencies.
- LUCAS Chest Compression Devices:** Two LUCAS Chest Compression Devices were awarded by the Placer County Ambulance Advisory Committee and S-SV EMS Agency. The award amount is \$53,000 and will greatly increase our ability to perform lifesaving efforts.
- RadioMobile IQ Mobile Software:** The Auburn Fire Department fleet has been equipped with tablets that link directly to the Grass Valley Emergency Command Center. These tablets provide a live interface with CAD and support the closest resource concept via Automatic Vehicle Location.
- Community Risk Reduction Program:** Lindsay Davidson was hired as CRR Program Manager and started with the Auburn Fire Department on May 10th.

Significant Emergency Incidents

STRUCTURE FIRE

May 26th – Auburn Fire resources with automatic aid from CAL FIRE and Newcastle Fire District responded to a residential structure fire at 113 Pleasant Avenue. Auburn Fire resources arrived to find smoke showing from the exterior of a two-story apartment. Firefighters evacuated the structure and extinguished a fire inside one of the interior walls. The location of the fire, inside the wall, made for difficult access. The cause of ignition was from pinched electrical lines. PG&E isolated the power to the source. The property owner took control of the structure and residents were able to return.

STRUCTURE FIRE

May 30th – Auburn Fire resources, with automatic aid from CAL FIRE, responded to a reported residential structure fire for a BBQ on fire inside 5075 Eagles Nest. Auburn Fire resources arrived to find a 5,500 ft² residence with nothing showing from the exterior. Firefighters contacted the homeowner and were advised the structure was evacuated and the fire had been extinguished with a dry chemical fire extinguisher. Firefighters secured the utilities to the structure and performed overhaul operations around the area of origin. PG&E isolated the power and gas supply to the area of origin. The property owner took control of the structure and residents were able to return.
