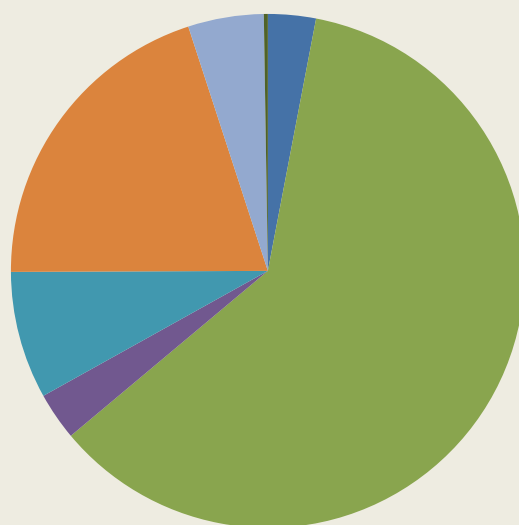

News & Events

- Strike Team Deployment:** Battalion 12 responded as the Task Force Leader Trainee to the Mosquito Fire and was assigned for 10 days to the incident.
- Inter-Agency Training:** Auburn firefighters have been training with both the Grass Valley Emergency Command Center and the Placer County Dispatch Center focusing on resource deployment and collaboration between agencies.
- Cal Chief's Conference:** Members of the Command Staff attended the 2022 Annual Cal Chief's Conference at the SAFE Credit Union Convention Center in Sacramento. Multiple fire service leaders presented information related to current and relevant fire service topics.
- Auburn Fire Open House:** The Auburn City Fire Department hosted an Open House on October 9th to kick off Fire Prevention Week. The theme of the event was "Fire won't wait. Plan your escape" and focused on simple but important actions families can take to keep themselves and those around them safe from home fires.

Significant Emergency Incidents

VEGETATION FIRE

September 30th – Auburn Fire units, with automatic aid from CAL FIRE/Placer County Fire, responded to a reported vegetation fire at the City of Auburn Wastewater Treatment Plant. Fire units arrived at scene to find approximately 1/8 acre of grass burning underneath one of the solar arrays that provide power to the facility. Fire resources extinguished the fire and performed a cause and origin determination. Auburn Police Department was requested to assist with obtaining information for the investigation. Representatives from the Wastewater Treatment Plant and solar contractor were requested to respond to the incident. The incident was stabilized with limited damage to infrastructure and the Wastewater Treatment Plant remained fully operational.

VEHICLE VS PEDIATRIC

October 9th – Auburn Fire Engines 1285, 1284 and B12 responded code 3 to ARD, 123 Recreation Drive for 4-year-old boy who was struck by a car. Crews arrived at scene and immediately began CPR and life saving measures on the critical patient. AMR transported to Sutter Roseville Medical Center (SRMC) with two of our Firefighters on board. While en route to the hospital the patient regained ROSC (Return of Spontaneous Circulation) after high quality CPR. The patient remained in critical condition at SRMC for several days. As of today, our young patient is feeling much better, out of the ICU and on a pediatric floor, following all commands, walking, talking, and eating like a champ!
