2           RESOLUTION AUTHORIZING THE APPROVAL OF RECERTIFICATION  
3           OF THE CITY'S SEWER SYSTEM MANAGEMENT PLAN IN ACCORDANCE WITH  
4           THE CALIFORNIA STATE WATER RESOURCES CONTROL BOARD'S ADOPTED  
5           STATEWIDE GENERAL WASTE DISCHARGE REQUIREMENTS FOR SANITARY  
6           SEWER SYSTEMS, WATER QUALITY ORDER NO. 2006-003.

8 THE CITY COUNCIL OF THE CITY OF AUBURN DOES HEREBY RESOLVE:

10 WHEREAS, on May 2, 2006, the California State Water Resources  
11 Control Board adopted Statewide General Waste Discharge Requirements for  
12 Sanitary Sewer Systems, requiring owners of public sanitary sewer collection  
13 systems to prepare a Sewer System Management Plan (SSMP); and

15 WHEREAS, the SSMP is a document that addresses procedures to operate,  
16 maintain and manage wastewater collection systems; and

18 WHEREAS, utilization of the SSMP provides the guidelines and procedures to  
19 reduce the number and frequency of sanitary sewer overflows (SSOs) and  
20 thereby decrease the risk to human health and the environment in our  
21 community; and

23 WHEREAS, on February 27, 2017, the City Council approved and certified  
24 the Sanitary Sewer Management Plan; and

26 WHEREAS, the SSMP must be updated every five (5) years, and must  
27 include any significant program changes, and re-certification by the  
28 governing board of the legislative body is required in accordance with

1 Section D.14 of the Order when significant updates to the Sanitary Sewer  
2 Management Plan are made.


