# FIRE CHIEF'S MESSAGE



The Auburn Fire Department is committed to fostering the safety and development of our community through prevention, public education, and emergency response with pride and honor. Serving nearly fifteen thousand residents, we continue to deliver exceptional all-risk emergency services while adapting to the evolving needs of our community.

The 2024 Annual Report highlights our department's achievements, challenges, and progress over the past year. In 2024, we faced difficult decisions, including closing the Maidu Fire Station due to budget constraints and staffing reductions. This decision was made to establish a sustainable service delivery model that prioritizes efficiency and the well-being of our personnel.

Despite these challenges, the department remained focused on its mission. A significant amount of staff time was dedicated to the Baltimore Ravine Shaded Fuel Break Project. In preparation for this important wildfire prevention project, we completed a CEQA study and selected a vendor to complete the project, with work beginning in early 2025. Additionally, we submitted an Assistance to Firefighters Grant in December in hopes of securing funding to support fleet replacement, demonstrating our commitment to identifying alternative funding sources to enhance operational readiness and support our budgetary needs.

We also strengthened relationships with external stakeholder groups and implemented two major fire prevention ordinances: Zone 0 requirements for all new construction and the Defensible Space Inspections for real estate transactions within Very High Fire Hazard Severity Zones.

Throughout the year, the department worked diligently to meet state-mandated requirements, including equipment maintenance, annual training, and inspections of multi-family dwellings and educational facilities. These efforts were in addition to responding to 2,462 emergencies and supporting the California Master Mutual Aid system.

Looking forward to 2025, we remain hopeful for new opportunities to enhance our services and the safety of our community. I want to extend my deepest appreciation to the dedicated Auburn Fire Department professionals and thank our community for their continued support.





# NEW TECHNOLOGY




Firefighter training with new SCBA and RIT-PAK

Our firefighting capabilities have improved with the replacement of our entire Self-Contained Breathing Apparatus (SCBA) inventory. The new equipment replaced equipment purchased in 2009 utilizing a FEMA Assistance to Fire-fighters Grant. The Auburn Fire Department was the only agency in Placer County that was not included in a 2019 regional grant opportunity that upgraded all other fire agencies to Scott SCBAs. This left Auburn Firefighters without the ability to interoperate on critical incidents. The upgraded technology includes:

- Thirty (30) Air-Pak X3 PRO SCBAs with Snap-Change, Parachute Buckles, 5.5 Standard No Accessory Pouch, E-Z Flo+ C5 Regulator with Quick Disconnect Hose, and Universal EBSS
- Sixty (60) SCBA Cylinders with Valves
- Thirty (30) Vision C5 Facepieces with Kevlar Straps
- Two (2) RIT-PAK III Rapid Intervention Team (RIT) Packs with Hoses, Mask and Regulators
- Two (2) 60 Minute, 5,500psi RIT-PAK Cylinders
- One (1) SCBA Tool Adapter – Quick Change to CGA Fittings
- Bauer Compressor 5,500psi Fill Station – Retrofit








**Simultaneous calls for service** are all calls that occur while one resource is still committed to a previous call.




Firefighter practicing hose deployment skills. Hose management training helps firefighters improve speed and accuracy, reducing the time needed to locate and extinguish fires.

## TRAINING HOURS BY CATEGORY





Justin holds an Associate's Degree in Fire Technology and Firefighter I & II, Driver/Operator, and Hazardous Materials Technician certifications. He also worked as a Confined Space Rescue Technician, providing standby rescue services for PG&E and the California Department of Water Resources.

# **SIGNIFICANT INCIDENTS**

## **February —Canal Overflow into Senior Apartments**

On February 5th, residents of 618 Mikkelsen Drive experienced significant flooding again. The first incident occurred in December of 2023 and residents had just returned after repairs were completed. Battalion 12, Engine 1282, and Engine 1273 responded to reports of major flooding affecting eight lower-level apartments. A resident activated a fire alarm pull station to alert emergency responders. Upon arrival, Engine 1282 confirmed major flooding and requested an expedited response from PCWA. Battalion 12 assumed command, overseeing evacuations while Engine 1273 reset the fire alarm panel. The flooding was determined to have originated from the canal above the property. PCWA Loss Prevention and Operations personnel worked to divert the water, and apartment management was notified. The City of Auburn Building Official, Fire Chief, and Red Cross were also contacted to assess the situation and provide assistance to displaced residents. Once the flooding subsided, the property was turned over to on-site management.

## **February —CO Poisoning at a Restaurant**

On February 14th, Engine 1282 responded to a medical aid at 175 Palm Avenue, where multiple patients complained of symptoms of illness and displayed signs of altered mental status. While assessing the scene, Engine 1282 detected dangerously high CO levels, peaking at 1,226ppm. The crew immediately evacuated the building, secured the gas at the water heater, and ventilated the structure while notifying dispatch. Battalion 12, the Auburn Police Department, and PG&E were dispatched to the incident. PG&E arrived and found CO levels ranging from 999 to 4,000 ppm in the kitchen area. PG&E issued a hazard notice and secured the gas to the business. The hospital confirmed that the transported patients had elevated CO levels in their blood. B12 notified the City of Auburn Building Official and terminated the incident.

## **December —Hit-and-Run into a Fire Hydrant with Flooding**

On December 6th, Battalion 12 and CAL FIRE Engine 2351 responded to a vehicle accident involving a fire hydrant near 172 Lincoln Way. Auburn Police Department reported that the vehicle fled the scene, leaving water flowing from a sheared hydrant. Battalion 12 assumed command and requested resources to assist with shutting off the water and conserving property. Placer County Water Agency and PG&E assisted with securing the water supply and utility services to the affected properties. Locating the water shut-off was challenging due to nighttime conditions and debris covering the valve, but it was eventually secured. Fire personnel focused on life property conservation efforts, using dam, dike, and divert tactics while assisting affected residents. The City of Auburn Building Official was notified to assist with the restoration efforts. Once mitigation efforts were completed, command was terminated, and properties were returned to tenants and management.


