

RESOLUTION NO. 24-108

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AUBURN  
REESTABLISHING A YOUTH ADVISORY COMMISSION

THE CITY COUNCIL OF THE CITY OF AUBURN DOES HEREBY RESOLVE:

WHEREAS, the City Auburn desires to foster involvement of young people in the work of the City; and

WHEREAS, the reestablishment of a Youth Advisory Commission is an appropriate means to foster that involvement; and

WHEREAS, the Auburn City Council previously established a Youth Commission in 2006 and now would like to reestablish that Commission.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF AUBURN DOES  
HEREBY RESOLVE:

1. Commission Created; Purpose. The Youth Advisory Committee is hereby reestablished to serve as an advisory body to the City Council in matters related to the needs of youth in the Auburn area and to promote youth involvement in the community.

2. Eligibility. Any resident of the greater Auburn Area who will be (i) of middle- or high school-age during the next school term following his or her appointment or (ii) involved in teaching, social services, or other activities directed at the young people of the greater Auburn area is eligible for appointment to the Commission.

3. Members and Officers. The Commission shall have 10 members, including a City Council Member who shall serve as chairperson and liaison to the City Council. All members shall be appointed by the City Council and serve

1 for a term of one year, ending on June 30th of each year. A member may be  
2 reappointed one or more times in the discretion of the City Council. It is the  
3 intent of the City Council to accomplish a diverse membership, representing  
4 schools and organizations which serve the young people of the community.  
5 Members are expected to serve as liaisons between the City and the school  
6 or youth group which they represent.

8 4. Tenure; Compensation and Expenses. Commission members shall  
9 serve without compensation and shall incur no expenses chargeable to the  
City without prior authorization of the City Council.  
10

11 5. Quorum; Attendance. A majority of the members of the Commission  
12 then in office shall constitute a quorum for the conduct of business. The  
13 Commission Chairperson shall inform the City Council of any member who fails  
14 to attend three meetings in any 12-month period and the City Council may  
15 excuse the absences or replace the Commission member in its discretion.  
16

17 6. Brown Act and Conflicts of Interest. All meetings of the Commission shall  
18 be held in compliance with the Ralph M. Brown Act, Government Code Sections  
19 54950 et seq. and members of the Commission shall conduct themselves  
20 consistently with state laws governing potential conflicts of interest, including  
the Political Reform Act of 1974, Government Code Sections 81000 et seq.

22 7. Amendments. This resolution may be amended from time to time by  
action of the City Council.
